

**City of Yakima
Revenue Development Area
Car Dealers and Leasing Companies
Effective January 1, 2009**

Effective January 1, 2009, the City of Yakima will establish a Revenue Development Area (RDA) in order to undertake community revitalization. The RDA is an area within the City of Yakima defined by the attached map (see back of notice). Activity within the RDA should be reported to location code 3983. The new location code represents a reporting change only; **the rate has not changed**.

The retail sale or use of motor vehicles, and the lease of motor vehicles for up to the first thirty-six months of the lease, **are exempt from the public safety tax imposed**.

Special Reporting Instructions for Sales or Leases of Motor Vehicles:

Businesses that report sales or leases of motor vehicles within the RDA (for up to the first thirty-six months of the lease) will need to report using the following location codes and tax rates:

Below is an example of how to report local retail sales tax on your excise tax return assuming sales of motor vehicles total \$50,000 and repairs total \$10,000 in the City of Yakima RDA.

Represents retail sales/services.

Represents only motor vehicle sales/leases.

Motor Vehicle Sales/Leases (eff. 7/1/03)	50,000	00	.003	150	00

Note: The three-tenths of one percent (.003) Motor Vehicle Sales/Lease Tax that was implemented July 1, 2003 still applies to the sale, lease, or rental of motor vehicles.

Reporting Instructions for Retail Sales:

Businesses that report retail sales within the RDA (**other than sales or leases of motor vehicles**) will need to report using the following location codes and tax rates:

Yakima (City) RDA	3983	.017	.065	.082


