

**City of Stanwood  
Transportation Benefit District  
Effective July 1, 2013**

*Effective July 1, 2013*, the City of Stanwood will establish a Transportation Benefit District (TBD). Sales and use tax within the City of Stanwood will increase two-tenths of one percent (.002). The tax will be used for transportation services. The new sales tax rate in Stanwood TBD is .088.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within the City of Stanwood (3116). Persons or businesses within the City of Stanwood will be subject to the new tax rate for reporting use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rate of sales tax is:
