

## Items for dual purposes

If you don't know at the time of purchase whether item(s) will be consumed or resold, you must purchase according to the general nature of your business.

- If your business principally (more than 50 percent) consumes the item(s), you should not use a reseller permit for that purchase.
- If your business principally resells the item(s), you may use a reseller permit and then report use tax on the item(s) consumed.

## Permits may be revoked

You, as the buyer, are solely responsible for paying the appropriate taxes (sales tax or use tax) on all purchases. Misuse of your reseller permit:

- Subjects you to a penalty of 50 percent of the tax due, in addition to the tax, interest, and penalties imposed.
- May result in your permit being revoked.

## Businesses (sellers) accepting reseller permits

**If you accept reseller permits, please follow these rules:**

- To make sales without collecting sales tax, you need to obtain a valid reseller permit or exemption certificate.
- You must keep either paper or electronic copies of the reseller permit.
- If a business does not have a valid reseller permit or exemption certificate on file with you, you need to collect sales tax.
- You may refuse to make a sale without charging tax if you have reason to believe:
  - your customer is not reselling the items.
  - the permit is expired or otherwise not valid.
- For audit purposes, you must keep reseller permits on file for five years from the date of last use.

As part of the audit process, the Department of Revenue routinely examines purchases made with reseller permits to verify the permits are being used appropriately.

Sellers are not responsible for uncollected sales tax if they have a valid reseller permit or exemption certificate that supported the sale.

# Effective JAN 1<sup>st</sup> 2010

Resale certificates are no longer valid. To purchase items for resale without paying sales tax, you must provide the seller with a copy of your reseller permit.

## Things to know about your reseller permit

**Permit number:** This number is unique to your business. The last two digits of your permit number are the year it expires.

**Effective dates:** Your permit's effective dates are listed in the upper-right corner of the permit.

**Verification:** Beginning in January 2010, businesses accepting reseller permits may check the Department's online database to make sure permits are valid.

**Misuse:** Misuse of your permit may result in penalties and the permit being revoked.

## Using your reseller permit

Provide a copy (paper or electronic) to each business from which you purchase items for resale. If you don't provide a copy, the business will need to charge you sales tax on your purchases.

### Use your reseller permit to buy:

- Merchandise and inventory that you directly resell without using.
- Ingredients, components, or chemicals used in processing new products for sale.
- Feed, seed, seedlings, fertilizer, and spray materials if you are a farmer.
- Materials and contract labor for retail/wholesale construction.
- Items for dual purposes (see back of this brochure).

### Do not use your reseller permit to buy:

- Items for personal or household use.
- Items used in your business that are not resold, such as office supplies and equipment.
- Promotional items or gifts.
- Tools, equipment, or equipment rentals.
- Materials and contract labor for public road construction or U.S. government contracting (see back of permit for more information).
- Materials and contract labor for speculative building (see back of permit for more information).

If your business is a...	You may use your permit to purchase...	You may not use your permit to purchase...
Contractor performing custom construction projects, painting contractor, electrical contractor, plumber	Materials that become part of the completed project, and subcontractor services.	Hand tools, power tools, equipment (rented or purchased), ladders, rollers, brushes, or supplies (tape, sandpaper, drop cloths).
Contractor performing speculative building, public road construction, or U.S. government contracting	Nothing. The permit may not be used to purchase anything when performing these types of construction projects.	Any materials, subcontractor services, supplies, or equipment (rented or purchased) related to these projects.
Competitive telephone service provider	Products or services provided to consumers as part of telephone service.	Tools, equipment, leasehold, or building improvements, cable, switching equipment, and supplies.
Restaurant or caterer	Meal ingredients, liquor, beer, wine, and soft drinks. Also purchases for "to-go" food sales (i.e. paper/plastic plates, cups, lids, plastic utensils, paper napkins, straws, and "to-go" food containers).	Furnishings (chairs, tables, décor), leasehold or building improvements, dishes, silverware, plastic trays, guest checks, printing services, cleaning supplies, office supplies, pest control services, tap cleaning, equipment (purchased or rented – ovens, grills, coffee makers), repair/parts/labor, and vending machines.
Automotive repair shop, service station	Tires, batteries, auto parts, antifreeze, and oil sold to customers.	Tools, equipment, building improvements, shelves, shop supplies and cleaning supplies, such as rags and hand cleaner.
Physician's practice, accounting company, architecture firm, real estate agency or any professional service business	Nothing. (Professional service businesses are consumers of all materials and supplies used in performing their services.)	Office furniture, equipment, leasehold or building improvements, software, magazine/subscriptions, and supplies used in the business.
Janitorial service company	Nothing. (Janitorial service businesses may not use a permit unless they directly resell and report retail sales of cleaning supplies.)	Supplies or equipment used in performing cleaning services, and office supplies/equipment.
