WASHINGTON STATE DEPARTMENT OF REVENUE LOCAL SALES TAX CHANGE

Snohomish County Transportation Tax Effective April 1, 2016

Effective April 1, 2016, sales and use tax within Snohomish County Public Transportation Benefit Area (PTBA) will increase three-tenths of one percent (.003). The tax will be used for transportation services.

The PTBA boundary does not include the cities of Everett or Everett Non-RTA; nor does it include a portion of Unincorporated Areas of Snohomish County.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Snohomish County. Persons or businesses within Snohomish County will be subject to the new tax rate for reporting use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rate of sales tax is:
