Instructions

To qualify for this credit you must:

- sell electricity, natural gas, or manufactured gas to an aluminum smelter.
- specify in a contract that the price of the electricity or gas will be reduced by an amount equal to the credit.

To calculate the credit:

- Multiply the gross amount of sales to the aluminum smelter by the corresponding rate of Business & Occupation (B&O) Tax and/or Public Utility Tax (PUT). This is the amount of your credit.
- Add Total Credit from lines 4 and 7 and enter the total amount on line 8.
- Complete the form below and mail with your Excise Tax Return.
