

Linda Williams is the Chair and public member of the Board. She was appointed by Governor Inslee in December 2016. Linda received her BA in English and her Juris Doctor from the University of Washington. She served as a hearings judge and review/mediation judge with the BIIA for nearly 20 years. She has also served as an Assistant Attorney General representing the Department of Labor and Industries, was Section Chief for the division's Olympia office, and served as program advisor to the Crime Victims Compensation Program. Her term expires on June 17, 2021.

Lynn D.W. Hendrickson is an Assistant Chief Industrial Appeals Judge in the Seattle office of the Board of Industrial Insurance Appeals. Prior to September 1999 she was an Assistant Attorney General in the Washington State Office of the Attorney General for 11 years, representing the Department of Labor and Industries, the Lemon Law Administration, and the Washington State Apprenticeship and Training Council. She is a frequent presenter at CLEs on professional and public employee ethics, legal writing, evidentiary topics, and matters related to workers' compensation and industrial safety and health.
