

**Yakima County  
Mental Health Tax  
Effective April 1, 2020**

**Effective April 1, 2020**, local sales and use tax within Yakima County will increase one-tenth of one percent (.001). The tax will be used for chemical dependency or mental health purposes.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Yakima County. Persons or businesses within Yakima County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rates of sales tax are:
