## Vehicle-Related and Scrap Metal Business Fee Description Sheet

- Use this list to select the vehicle-related endorsements required for your business. (You may request any of the listed endorsements and related license plates and/or permits necessary for vehicle related business conducted at the same location with a single application. Each location requires a separate application.)
- 2. List the applicable endorsements and their fees in Section 2 on page one of the Business License Application.
- 3. To apply for the endorsements on this sheet you must complete a *Business* License *Application* and one or more of three addendum forms.
  - To obtain any of the vehicle and vessel dealer and manufacturer endorsements, complete the *Vehicle Dealer/Manufacturer* Addendum form.
  - For any of the **principal** location endorsements for vehicle transport and disposal endorsements (see page 2), complete the *Vehicle Transport/Disposal Addendum* form.
  - For the **RTTO Branch Storage Site** or **Motor Vehicle Wrecker Branch** endorsements, complete the *Vehicle Transport/ Disposal Branch Site Addendum* form.
  - For any of the Scrap Metal Business endorsements, complete the Scrap Metal Addendum (see page 2)

## Vehicle and Vessel Dealer and Manufacturer Endorsements

Motor Vehicle Dealer	\$975
Each MV dealer license plate	\$50.75

Required for businesses that buy or sell new or used cars, trucks, and/or motor-homes at retail or wholesale. Also required for Auctioneers selling titled vehicles.

Motor Vehicle Dealer Subagency *	<b>\$100</b>
Each MV dealer license plate	\$50.75
Required for each additional business location after the	e first,

primary Motor Vehicle Dealer business location has been endorsed.

Manufactured Home-Travel Trailer Dealer	\$975
Each MH/TT dealer license plate	\$50.75

Required for businesses that sell any type new or used nonmotorized mobile, manufactured home, park trailer, travel trailer or tent trailer at retail or wholesale.

# Mfd. Home-Travel Trailer Subagency \*\$100Each MH/TT dealer license plate\$50.75

Required for each additional business location after the first, primary Manufactured Home-Travel Trailer business location has been endorsed.

Miscellaneous Vehicle Dealer	\$975
Each motorcycle dealer license plate	\$44.75
Each miscellaneous vehicle dealer license plate	\$50.75

Required for businesses that sell, at retail or wholesale, motorcycles, neighborhood electric vehicles and any miscellaneous vehicle other than motor vehicles, mobile homes, fifth wheel trailers, tent trailers and travel trailers (i.e., this endorsement allows the sale of off-road vehicles, and utility, boat, and/or horse trailers).

Misc. Vehicle Dealer Subagency *	\$100
Each motorcycle dealer license plate	\$44.75
Each miscellaneous vehicle dealer license plate	\$50.75
Required for each additional business location after the	e first,

Vehicle Manufacturer Each manufacturer license plate	\$500 \$50.75	
Required for businesses that manufacture or assemble new		
vehicles or to remanufacture used vehicles for transfer to		
Washington dealerships for resale. Also covers factory branches,		
representatives, and/or distributors.		

Off-Road Vehicle Dealer	\$25
Each off-road dealer license plate	\$4

Required for businesses that do not hold a Miscellaneous Vehicle Dealer endorsement, but sell any motorized vehicles (other than snowmobiles, and/or water vessels) intended for use on trails or cross-country. Each business location must be registered separately.

Snowmobile Dealer	\$25
Each snowmobile dealer license plate	\$4

Required for businesses that sell motorized snowmobiles intended for recreational use on non-highway roads, or crosscountry. Each business location must be registered separately.

Vessel Dealer	\$120
First vessel dealer decal & certificate	\$40
Each additional vessel dealer decal & certificate	\$20

Required for each business location that sells, at retail or wholesale, any watercraft designed for either motor or wind propulsion, or 16 feet or longer in length, even if unpowered.

Vehicle	Transport	and Di	sposal	Endorsements

Registered Tow Truck Operator (RTTO)	\$100
Each tow truck permit	\$50

Required for businesses that transport, impound, and/or store unauthorized vehicles or dispose of abandoned vehicles. Each tow truck used by the operator must have a valid permit.

#### **RTTO Branch Storage Sites \***

No fee

Required for each additional vehicle storage/impound area located away from the main business location. Registration of each additional area requires a separate application. (Tow trucks are registered only at the main business location.)

Vehicle Transporter	\$25
Each transporter license plate	\$2

Required for businesses that transport motor vehicles not owned by the transporter company itself, over any roads in Washington. Separate plates are required for each vehicle driven under its own power.

Hulk Hauler	\$10
First hulk hauler license plate	\$5
Each additional hulk hauler license plate	\$2

Required for businesses that transport and/or sell wrecked titled or registered vehicles to motor vehicle wreckers and/or scrap processors. Each vehicle used to conduct business must have a hulk hauler license plate. Each business location must be registered separately. Each location must maintain separate license plates for vehicles used at that site.

Motor Vehicle Wrecker	\$25
First motor vehicle wrecker license plate	\$5
Each additional wrecker license plate	\$2

Required for businesses that buy or sell wrecked titled or registered motor vehicles for the purpose of dismantling them, or to buy or sell second-hand motor vehicle parts. Each vehicle used to conduct business must have a wrecker license plate.

Motor Vehicle Wrecker Branch *	No Fee
Each additional wrecker license plate	\$2

Required for each additional business location of a vehicle wrecker in the same county, after the first location has been registered. Registration of each additional site requires a separate application.

Motor Vehicle Salvage Processor	\$25
First salvage processor license plate	\$5
Each additional salvage processor plate	\$2

Required for businesses that maintain a hydraulic baler and shears or shredder to recycle salvage from wrecked titled or registered vehicles. Each vehicle used to conduct business must have a scrap processor license plate. Each business location must be registered separately. Each location must maintain separate license plates for vehicles used at that site.

## Scrap Metal Business Endorsements - Non-Vehicle Related Scrap Only

Scrap Metal Processor	\$1,250
First scrap metal processor license plate	\$5
Each additional scrap metal processor plate	\$2

Required for businesses at a fixed location engaged in purchasing or receiving **non-vehicle related** scrap metal property and maintaining a hydraulic baler, shearing or shredding device for the purpose of altering the metal for the use as feedstock in the manufacture of new products.

Scrap Metal Recycler	\$1,250
First scrap metal recycler license plate	\$5
Each additional scrap metal recycler plate	\$2

Required for businesses at a fixed location engaged in purchasing or receiving **non-vehicle related** scrap metal property for the purpose of aggregation and sale to another scrap metal business.

Scrap Metal Supplier	\$350
First scrap metal supplier license plate	\$5
Each additional scrap metal supplier license plate	\$2

Required for businesses without a fixed business location engaged in purchasing or receiving **non-vehicle related** scrap metal property for the purpose of aggregation and sale to a scrap metal recycler or a scrap metal processor. **Note:** Applicants for this endorsement must provide the address of the business office where their business records may be accessed when providing the "Business Location Address" on the application.

• All **subagency** and **branch** endorsements are for **additional** business locations for each of those endorsements. The principal location endorsement must already have been issued, or requested on a separate application, before requesting the related branch or subagency endorsement.

To obtain *Temporary* Vehicle Dealer Subagency permits, contact the Department of Licensing, Dealer Services at 360-664-6466. Temporary subagency permits are not available through the Business Licensing Service.
