Schedule C2 (Smokeless Tobacco) Instructions



Note for In-State Distributor's report of interstate sales: If smokeless tobacco has the tax paid for the state delivered to, you may combine the total of all such sales on one line (per state).

Exempt reason

If you answered "no" to tax being paid, provide the reason code for why it was not paid.

Exempt reason codes

- 1. Out-of-State, Destination State Tax Paid
- 2. Out-of-State, Destination State Tax Not Paid
- 3. Military
- 4. Tribal
- 5. Export, Outside U.S.
- 6. Other Exempt Reason

Brand family and product description

Under "Brand family," enter the brand family only. Under product description, list the full product name.

For example:

Brand family	Product description					
Camel Snus	Camel Snus Frost Large					
Stokers	Stoker's Long cut Natural 1.2 oz.					

Quantity reporting

- Quantity (cans/packs) per packaging: How many cans are in the package or multipack?
- Quantity shipped: How many multipacks did you sell/ship?
- Total Quantity (cans/packs): What is the total number of cans or packs sold/shipped?
- Total weight: What is the total weight of all product sold/ shipped?
- For example, if one roll of chewing tobacco has 5 cans, you sold 50 rolls, and each can is 1.2 ounces, you would report:

Quantity reporting example:

Qty (cans/packs) per packing			Total weight (oz)
5	50	250	300

Rules and laws

- Washington Administrative Code 458-20-185 Tax on tobacco products.
- Title 15, Chapter 10A, section 376, U.S. Code (commonly referred to as the "Jenkins Act"; amended by the Prevent All Cigarette Trafficking (PACT) Act in 2010).

Note: Filing of this report on interstate shipments into Washington may also satisfy the requirement of the federal Jenkins Act.
