Local sales/use tax changes

(Effective July 1, 2020)

City of Anacortes

Sales and use tax within the City of Anacortes will increase one-tenth of one percent (.001). The tax will be used for housing and related services.

San Juan County

Sales and use tax within all of San Juan County will increase two-tenths of one percent (.002). The tax will be used for emergency communication services.

Motor vehicle sales and use tax

Motor vehicle dealers and motor vehicle leasing companies must collect the additional sales tax of three-tenths of one percent (.3%) of the selling price. This applies to every retail sale or lease of a motor vehicle in Washington. "Motor vehicle" means every vehicle that is self-propelled as defined in RCW 46.04.320. However, this does not include farm tractors, farm vehicles, off-road vehicles, non-highway vehicles, and snowmobiles.
