NOTES ON THE LOCAL TAX DISTRIBUTIONS REPORT

Overview-- The Office of the State Treasurer disburses local tax distributions to cities, counties and other local governments. The Department of Revenue (Department) collects these taxes and is accountable for distributing taxes to the appropriate jurisdictions. The Distribution column represents retail sales and use tax amounts remitted to the Department in the previous month. (Example: March 2019 distribution generally includes the January 2019 return due in February 2019.)

Beginning in March 2019 the updated local tax distribution query allows the public to view data by single or all locations without using separate queries. The data from 2012-present has been converted into the new format. Use the search bar in the query after clicking search to view distribution by year, month, tax or location. Export data into spreadsheet or HTML view. For more information on how to use the distribution query, click the "Navigation Guide".

The previous distribution query (1983-2011) displayed the taxes by tables from Table 1 to 17. The current query allows users to select one, some or all distribution taxes. Click the link "How To Match Older Data" to see how to match the tables from 1983-2011 to the taxes in the 2012-present queries.

Data Presentation-- The tax types presented in the annual report are the following:

- Sales/Use
- Lodging
- Rental car
- Enhanced 911

Due to process changes in our current system, the state administration fee and the E911 number of lines are no longer included in the reports. While some formats have changed, the figures included are identical to those presented in other media.

The amounts displayed for Criminal Justice (85/86) and Public Safety County (131/132) will differ from the amounts distributed from 2012 thru March 2018. The amounts displayed are the total amounts collected for the county. The Office of the State Treasurer using population data calculates the final distribution amounts.

We caution all users of this data to take great care in attempting to attribute causes to individual percentage changes. Distributions can fluctuate dramatically due to population changes, annexations and incorporations, as well as audit adjustments.
