NOTES ON THE LOCAL TAX DISTRIBUTIONS REPORT

Overview-- Local tax distributions are amounts disbursed to cities, counties, and other local governments by the Office of the State Treasurer. The Department of Revenue (Department) collects these taxes and is responsible for the correct allocation of the funds. The Distribution amounts represents retail sales and use tax amounts remitted to the Department in the previous month. (Example: March 2019 distribution generally includes the January 2019 return due in February 2019). Distributions are monthly; however, jurisdictions receive a proportionate local sales tax funding when a business makes a payment, but does not pay in full. The funding method continues until the business pays the full amount.

Beginning March 2019 the updated local tax distribution query will allow the public to view data by single or all locations without using separate queries. The data from 2012-present has been converted into the new format displayed on the page. Users can easily search a year, month, tax or location from the drop down menu or typing it into the search bar. The data is easier to manipulate and can be downloaded into a spreadsheet file. The previous distribution query (1983-2011) displayed the taxes by tables from Table 1 to 17. The current query allows users to select one, some or all distribution taxes. Click this link "[How To Match Older Data](#)" to see how to match the tables from 1983-2011 to the taxes in the 2012-present queries.

Data Presentation--The formats used in this annual summary vary from the formats used in the monthly report on the Department's web site. The 2018 data is the current monthly distribution report format. The tax types are sales/use taxes, lodging taxes, and rental car/other taxes. Due to process changes in our new system, the state administration fee and the E911 number of lines are no longer included in the reports. A cross-section of representative users requested the development of the formats used in this publication. While some formats have changed, the figures included are identical to those presented in other media. This annual edition includes figures for both the most recent complete calendar year and the prior year. At our users' request, we have included a computation of the percentage change in distribution amounts from one year to the next. We caution all users of this data to take great care in attempting to attribute causes to individual percentage changes. Distributions can fluctuate dramatically due to population changes, annexations and incorporations, as well as audit adjustments.
