Due to budget cuts, the Department of Revenue will no longer provide pre-printed Real Estate Excise Tax (REET) forms.

- Print Instructions on back of last page only<sup>4</sup>
- Punch holes at top, 5/8' top stub
- 800 to a carton with bright slip sheets between every 25 sets (this depends on how you want them packed)

- 4 Part
  - Page 1 white Coating Back 15#
  - Page 2 canary Coating Front & Back 14#
  - Page 3 pink Coating Front & Back 14#
  - Page 4 goldenrod Coating Front 15#
- Red marginal words
- Print Instructions on back of last page only
- Punch holes at top, 5/8' top stub
- 600 to a carton with bright slip sheets between every 25 sets (this depends on how you want them packed)

## **Mobile Home REET Affidavits**

- Red marginal words
- Print Instructions on back of last page only
- Punch holes at top, 5/8' top stub
- 600 to a carton with bright slip sheets between every 25 sets (this depends on how you want them packed)
