### Adjustments to the Mitigation Data

Valerie reported that DOR received no adjustments from any jurisdiction. In August, DOR will send out a message letting all local jurisdictions know there is no change and that will complete the 2014 annual review process. By the end of August we will also send out the annual loss data through secure message.

#### Discuss LRF, LIFT and HBZ Inclusion

Valerie explained the computation of the voluntary compliance revenues for the mitigation process excluded the Local Infrastructure Financing (LIFT) and Local Revitalization Financing (LRF) state shared taxes. Including Hospital Benefit Zone (HBZ) state shared tax will have no impact on SST Mitigation payments. Including the LIFT and LRF state shared taxes will reduce SST Mitigation payments by approximately \$2,650 per year. This change currently impacts eight jurisdictions. Affected jurisdictions will receive a secure message by the end of August. These amounts will be included going forward – past payments will not be changed.

#### Discuss 2015 Annual Review

The 2015 review schedule for 2016 payments was reviewed. There were no concerns raised.

In August 2014, the data for review by local jurisdictions will be sent out. Local jurisdictions have until the end of April 2015 to review and send the Department any questions about businesses.

## Next Annual Meeting

Don Gutmann stated the next annual meeting will be held by conference call in July of 2015.
