Note: If, after a permit has been issued under RCW <u>88.02.620</u>, the department has reason to believe that the nonresident vessel owner was not eligible for the permit approved, the department may request such information from the nonresident vessel owner as the department determines is necessary to conduct a review of the nonresident vessel owner's eligibility.

If the department finds the nonresident person was not eligible for the permit, the department must assess against the nonresident person state and local use tax on the value of the vessel according to the "value of the article used" as defined in RCW 82.12.010. The department must also assess against the nonresident person any watercraft excise tax due under chapter 82.49 RCW. Penalties and interest as provided in chapter 82.49 RCW apply to taxes assessed under this subsection (4).
