

## WASHINGTON STATE DEPARTMENT OF REVENUE LOCAL SALES TAX CHANGE

## City of Monroe Transportation Benefit District Effective January 1, 2015

*Effective January 1, 2015*, the City of Monroe will establish a Transportation Benefit District (TBD). Sales and use tax within the City of Monroe will increase two-tenths of one percent (.002). The tax will be used for transportation services.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within the City of Monroe (3112). Persons or businesses within the City of Monroe will be subject to the new tax rate for reporting use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rate of sales tax is:
