| 1 | City of Waitsburg | The Walla Walla County Assessor (Assessor) provided the Department of Revenue (Department) with the City of Waitsburg levy calculation worksheet, for the 2019 tax year. The Assessor used the correct statutory maximum levy rate to calculate the statutory maximum dollar amount for the district. | Completed | No |
| 2 | Tax Roll Certification | The Assessor certified the 2019 tax roll to the Walla Walla County Treasurer (Treasurer) on January 16, 2019, after the January 15 deadline, required by statute. The Assessor's certification is dated January 16, 2018, this appears to be a typographical error. The Treasurer signed in receipt on January 16, 2019. The certification did not include the real and personal property values or levy rates for each taxing district. The Assessor's certification of the tax roll to the Treasurer must contain: real and personal property values, total tax amounts, and levy rates for each taxing district, in addition to certification language. The resolution serves as the county legislative authority's certification to the Assessor, of the taxing districts budgets, for the 2019 tax year.
