

**Thurston County  
Housing and Related Services  
Effective July 1, 2022**

**Effective July 1, 2022**, sales and use tax within Thurston County, except for Olympia, will increase one-tenth of one percent (.001). The tax will be used for housing and related services.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Thurston County. Persons or businesses within Thurston County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rates of sales tax are:
