This Certificate is for the taxable (assessed) value of all locally assessed real and personal property after revaluation is complete.

1. Forest Land Assessed Value

Show the assessed value of designated forest land. 6. Total Taxable Locally Assessed Value on Real

2. Current Use Land Assessed Value

Show the land value only of farm/agricultural, open space, and timber land classification.

3. Improvement Value Only on Improvements Located on Current Use Lands

This total should be the value of all buildings, permanent crops, and other improvements.

4. Taxable Senior Freeze Assessed Value

Show the assessed value of the property subject to taxation for regular levies (after the value is frozen, and the exemption from regular levies is removed). If this property is receiving a reduction under the senior exemption program (chapter 84.36 RCW) and the current use program (chapter 84.34 RCW), report on this line only the portion of the property eligible for the senior exemption.
