

Pierce County Housing and Related Services Effective July 1, 2023

Effective July 1, 2023, sales and use tax within Pierce County, except for Tacoma, will increase one-tenth of one percent (.001). The tax will be used for housing and related services.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Pierce County. Persons or businesses within Pierce County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

What to collect and report:

Lodging businesses with 26 or more rooms should report to the following location codes:

Lodging businesses located in Pierce County with 25 or fewer rooms should report to the standard location codes. Special Hotel/Motel (Pierce County):

- 25 or less rooms/spaces = .02
- 26 or more rooms/spaces = .05
- Fife, Lakewood and Puyallup = .05

Definition of Lodging Businesses:

"Lodging businesses," for the purpose of this reporting change, means a business that furnishes lodging taxable by the State of Washington under RCW 67.28.180.
