

**City of Bingen
Public Safety Tax
Car Dealers and Leasing Companies
Effective January 1, 2026**

Effective January 1, 2026, local sales and use tax within the City of Bingen will increase one-tenth of one percent (.001). The tax will be used for criminal justice purposes, fire protection purposes, or both.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within the City of Bingen. Persons or businesses within the City of Bingen will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

Special Reporting Instructions for Sales or Leases of Motor Vehicles:

Businesses that report sales or leases of motor vehicles (for up to the first 36 months of the lease) will need to report using the following location code and tax rate. After the first 36 months of motor vehicle leases, the original city code should be used.

Reporting Instructions for Retail Sales:

Businesses that report retail sales (other than sales or leases of motor vehicles) will need to report using the following location code and tax rate:

***In addition to the .001 Public Safety tax, Klickitat County has imposed the Criminal Justice tax on January 1, 2026, for a total rate increase of .002.**

Below is an example of how to report local retail sales tax on your excise tax return assuming sales of motor vehicles total \$50,000 and repairs total \$10,000 in the City of Bingen.

New sales tax applies i.e. service and parts.

Represents only motor vehicle sales.

The five-tenths of one percent (.005) Motor Vehicle Sales/Lease applies to the sale, lease, or rental of motor vehicles. **(This rate increased effective January 1, 2026, per new legislation SB 5814 from .003 to .005.)**
