LOCAL SALES TAX CHANGE

City of Cle Elum Transportation Benefit District and

Local Law Enforcement Programs Car Dealers and Leasing Companies Effective January 1, 2026

Effective January 1, 2026, local sales and use tax within the City of Cle Elum will increase one-tenth of one percent (.001) for Transportation Benefit District and will increase one-tenth of one percent (.001) for Local Law Enforcement Programs, for a total increase of two-tenths of one percent (.002). The tax will be used for transportation services and local law enforcement programs.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within the City of Cle Elum. Persons or businesses within the City of Cle Elum will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

Special Reporting Instructions for Sales or Leases of Motor Vehicles:

Businesses that report sales or leases of motor vehicles (for up to the first 36 months of the lease) will need to report using the following location code and tax rate. After the first 36 months of motor vehicle leases, the original city code should be used.

Reporting Instructions for Retail Sales:

Businesses that report retail sales (other than sales or leases of motor vehicles) will need to report using the following location code and tax rate:

Represents only motor vehicle sales.

The five-tenths of one percent (.005) Motor Vehicle Sales/Lease applies to the sale, lease, or rental of motor vehicles. (This rate increased effective January 1, 2026, per new legislation SB 5814 from .003 to .005.)
