LOCAL SALES TAX CHANGE

King County Local Law Enforcement Programs Effective January 1, 2026

Effective January 1, 2026, local sales and use tax within King County will increase one-tenth of one percent (.001). The tax will be used for local law enforcement programs.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within King County. Persons or businesses within King County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

The new rates of sales tax are:
