WASHINGTON STATE DEPARTMENT OF REVENUE LOCAL SALES TAX CHANGE

Yakima County Emergency Communication Tax Car Dealers and Leasing Companies Effective January 1, 2026

Effective January 1, 2026, local sales and use tax within Yakima County will increase two-tenths of one percent (.002). The tax will be used for emergency communication systems and facilities.

Businesses must collect the appropriate new rate of sales tax for retail sales and services provided within Yakima County. Persons or businesses within Yakima County will be subject to the new rate of use tax on items purchased for their personal or business use if sales tax has not been paid.

Special Reporting Instructions for Sales or Leases of Motor Vehicles:

Businesses that report sales or leases of motor vehicles (for up to the first 36 months of the lease) will need to report using the following location codes and tax rates. After the first 36 months of motor vehicle leases, the original city code should be used.
