Local sales/use tax changes

(Effective October 1, 2016)

City of Othello

Sales and use tax within the City of Othello will increase two-tenths of one percent (.002). The tax will be used for transportation services.

City of Mattawa

Sales and use tax within the City of Mattawa will increase two-tenths of one percent (.002). The rate change will be used for transportation services.

City of Ellensburg

Sales and use tax within the City of Ellensburg will increase two-tenths of one percent (.002). The tax will be used for transportation services.

Tools for finding local sales tax rates and codes

Operate your retail business knowing you are always charging your customers the right amount of sales tax. With our Tax Rate Lookup tools, all you need is the physical address or zip+4 of your business location or ship-to address. You will receive the local sales tax rate, corresponding local tax code, and a confirmation number so you can operate with confidence knowing your sales tax rates are correct.

Does the Department grant sales tax refunds to Nonresident travelers?

No. Generally, residents of other states and countries must pay sales tax on purchases they make while in Washington when they take delivery of the goods in this state. If the traveler pays sales tax to the retailer, they will not qualify for a refund of the sales tax from the Department of Revenue.

There is a limited sales tax exemption for certain nonresidents. This exemption is limited to residents of certain other states and Canadian provinces that have a sales tax of 3 percent or less. Even under this program, the sales tax exemption must be granted by the retailer at the time of sale. If the visitor pays sales tax to the retailer, the Department will not grant refunds. Attend a free tax workshop

Business owners in Washington are responsible for knowing which taxes to report. To help new and small business owners, the Washington State Department of Revenue will offer, over the next three months, 16 free tax workshops at various locations around the state. If you can't attend in person, sign up for a live broadcast webinar that covers the same information. Participants will learn about Washington excise taxes, reporting classifications, deductions, tax incentives, sales tax collection and record-keeping requirements. Attendees receive a workbook and helpful reference guide to Revenue's rules and regulations. Auto-generated or suggested gratuity added to an electronic check, bill, etc.

Many restaurants allow customers to pay through electronic means, applications (apps), on their customers' mobile devices, or through table kiosks, tablet computers, etc. accessed by customers.

Gratuity would be considered clearly voluntary and exempt from tax if the app or restaurant device did the following at the time of payment:

- makes clear that gratuity is voluntary by defaulting to a blank line or
- displaying \$0 value for the gratuity that the customer can freely adjust after the meal or service is provided and clearly makes the customer aware the gratuity is voluntary.

The above bulleted examples outline instances where the Department will presume that gratuity to be clearly voluntary. To the extent the opportunity to pay a gratuity differs from these examples, the Department will examine the facts and circumstances to determine whether or not the gratuity is 'clearly voluntary.'
